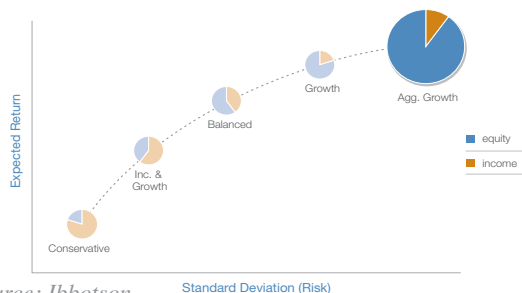

**ibbotson asset allocation portfolios expand the efficient frontier**

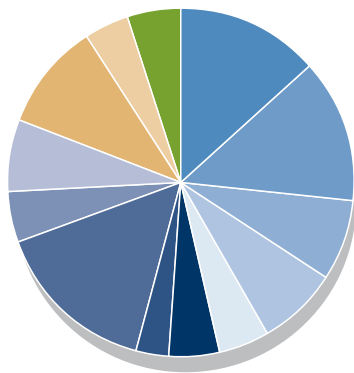
